THE POSITION

As the state's CIO, the Secretary serves as a member of Governor Jerry Brown's cabinet and advises the Governor on the strategic management and direction of information technology/resources for the state and directs the Technology Agency in minimizing overlap, redundancy, and cost in state operations through the promotion of efficient and effective use of IT. The Secretary provides leadership for the state's IT programs and works collaboratively with other IT leaders throughout the state.

Salary is \$175k/year and includes full benefits (see next page for details).

THE ENVIRONMENT

Previously the Office of the State Chief Information Officer, the Technology Agency was formally established through AB 2408 as a cabinet-level agency with statutory authority over IT strategic vision and planning, enterprise architecture, policy, and project approval and oversight. The Agency oversees IT projects and public safety emergency communications systems for all state departments and has a \$500M annual budget.

- 1. Describe your leadership experience that demonstrates an ability to use project oversight skills to guide the successful completion of multiple large IT projects.
- 2. In this position, describe what you would do to generate creative solutions to meet budgetary needs while simultaneously growing the capability of the state's IT community to deliver effective solutions.

The selection process will consist of a competitive evaluation of qualifications based upon a review of the application materials. Those candidates who demonstrate exceptional qualifications may be asked to continue in the selection process.
