Exempt Appointment

Under the administrative direction of the Deputy Director for Health Care Delivery Systems, the Long-Term Care Division Chief is responsible for providing the leadership, vision and directing the activities of the Long-Term Care Division. The Division Chief functions as the principal policy maker and advisor for all aspects of the Department of Health Care Services' (DHCS) long-term care programs and policies, which includes multiple and complex service programs. The Division Chief is responsible for developing, implementing, managing, and evaluating innovative long-term care programs that integrate service delivery and consolidate funding sources. This includes the Program of All Inclusive Care for the Elderly, the contract with SCAN Health Plan, Cal Medi Connect and Managed Long-Term Services and Support, and the Money Follows the Person federal grant project. The Division Chief is also responsible for managing the complex state plans, waivers, and home and community based services programs that enable vulnerable populations in California to receive needed care in their home or community, and is responsible for ongoing implementation and promotion of the California Partnership for Long-Term Care.

The Division Chief is the public face of the long term care programs for the Department and collaborates with other state departments to coordinate long-term care strategic policy planning; acts as a liaison between the Department and the public and private sector in developing collaborative partnerships to support a broader range of long-term care financing and service delivery options throughout the State; and facilitates philanthropic involvement to foster these innovations. The Division Chief fosters internal collaboration and partnership within various divisions of the Department. In this capacity, the incumbent provides expert policy guidance to the Administration and other statedepartments; responds to the Legislature, long-term care industry entities, public interest groups with concerns about the Department's long-term care policies and priorities; initiates and manages the development of all program policies and procedures; and oversees the administration of the long-term care programs, to ensure that all programs and services provided meet State and federal requirements, and that beneficiaries' health and safety are protected.
