DUTIES/RESPONSIBILITIES:

In an advisory capacity, the Deputy Commissioner of Legislation consults with and assists the Commissioner and Chief Deputy in identifying and analyzing policy problems, presenting solutions, and executing studies and reports relative to issues of legislation, or regulatory change. The incumbent is aware of the principles, practices and trends of the financial services industry under the Commissioner's jurisdiction and is knowledgeable in related public policies and legal actions that affect the regulation and supervision of licensees.

The Legislative Deputy advises and assists the Department of Business Oversight in the formulation and coordination of legislative proposals and projects, acts as liaison between the Legislature and the Department, keeps management informed on legislation of interest to the Department, and advocates the Department's position on legislation.

The Legislative Deputy directs the legislative affairs of the Department and is responsible for formal bill analysis with particular emphasis on determining a bill's genesis and purpose through consultation with Legislative staff and committees, as well as special interest groups and consumer organizations. Arranges and coordinates input and written analysis of pending legislation from program and Legal Division subject matter experts. Coordinates with the Legal Division in developing responses to legislative issues that are of direct concern to the Department. Evaluates issues related to the formation of new policies and reviews them with the appropriate manager and makes recommendations to executive committee members for the purpose of adopting a formal policy.

Initiates and responds to telephone calls and meetings with legislators, committee staff, and persons who support or oppose legislation. Manages special projects with legislators and various representatives of government and industry. Attends hearings; prepares bill status reports and upcoming hearing reports. Represents the Department and testifies before various committees, attends and participates in meetings and conferences as the legislative representative of the Department. This position is located in the Sacramento office.

GENERAL QUALIFICATIONS:

Candidate must possess essential personal qualifications including integrity, initiative, dependability, good judgment, and ability to work cooperatively with others.

DESIRABLE QUALIFICATIONS:

- 1. Demonstrated knowledge and understanding of California and federal law, regulations, policies and programs including the Government Code, Financial Code and other applicable laws and regulations.
- 2. Extensive working knowledge of the legislative process at both the federal and California State government levels.
- 3. Demonstrated communication and negotiation skills and experience testifying and presenting issues before a wide range of audiences, including the State Legislature, a board or similar body.
- 4. Demonstrated ability to effectively communicate, orally and in writing in the preparation of legislative proposals, and to provide technical assistance with the drafting of legislation.
- 5. Demonstrated ability to develop cooperative working relationships with representatives of all levels of government, the public, departmental executives and other governmental agencies.
- 6. Strong leadership skills and experience in the area of policy formulation and development.

CONDITIONS OF EMPLOYMENT:

The Deputy Commissioner of Legislation for the Department of Business Oversight is appointed by the Governor (i.e. "at will" employment): therefore, the Deputy Commissioner of Legislation may be terminated from service at any time without notice, cause, or right of appeal.
