JOB DESCRIPTION AND DUTIES:

Under the administrative direction of the Chief Deputy Superintendent, the Director of the Local Agency Systems Support Office (LASSO) is responsible for leading the implementation of the Local Control Funding Formula (LCFF), with specific focus on developing policies and processes for local education agency (LEA) submission and implementation of Local Control and Accountability Plans (LCAP).¹

The Director of LASSO will perform the following duties:

- Consult with CDE, State Board of Education, California Collaborative for Educational Excellence staff, and representatives of key stakeholder groups (e.g., California County Superintendents Educational Services Association school district/county office superintendents, other LEA administrators, etc.) to develop recommendations for regulations and evaluation rubrics governing and supporting the LCFF and the LCAP template and submission process.
- Consult with other divisions within CDE to align LCFF/LCAP requirements to existing processes and resources and develop technical assistance.
- Prepare for submission and review of LCAPs, including the CDE's review of County Office of Education LCAPs.
- Facilitate the planning, implementation, systems development, and evaluation of a cross-branch/division team, the CDE LCAP Support Team, dedicated to providing county offices and LEAs with resources and support for successful LCAP development and implementation.
- Make presentations and represent the State Superintendent of Public Instruction (SSPI) in dealings with other high level public officials, including state legislators and county and school district superintendents
- Provide leadership, direction, and technical expertise for the development, implementation, and evaluation of LCAPs.
- Serve as a member of the SSPI's Leadership Team by participating in the development, implementation, and evaluation of statewide and departmental policies and practices.
- Assist Chief Deputies with CDE organizational development initiatives as assigned.

DESIRED QUALIFICATIONS:

- Strong commitment to and skills in collaboration with internal and external partners.
- Experience and skill in understanding and navigating political and policy shifts and dynamics.
- Programmatic knowledge, including expertise in curriculum and instruction.
- Administrator or management experience in the K-12 educational system.
