JOB DESCRIPTION:

The California High-Speed Rail Authority (Authority) has an opening for an exempt, full-time Director of Maintenance and Operation. Under the general direction of the Assistant Chief Program Manager, the Director of Operations and Maintenance is responsible for advancing the Authority's implementation of the High-Speed Rail program. The incumbent will work closely and collaboratively with multiple Authority departments and Program Management staff and consultants in the development and execution of actions necessary for high-speed rail operations and on-going asset management. The incumbent has responsibility for the High-Speed Rail System's safety, security, operations, and maintenance activities.
