Under the administrative direction of the Undersecretary, Operations, the Director, Division of Rehabilitative Programs (DRP) is responsible for planning, organizing, and directing the statewide rehabilitative programs for adult inmates and parolees and related supportive program services. The Director, DRP, provides oversight of the Office of Offender Services (OOS), the Office of Correctional Education (OCE), and the Office of Program Accountability and Support (OPAS).

The OOS manages the in-prison and community components of the adult offender employment program and initiates/participates in efforts to obtain and sustain partnerships with various outside entities who contribute to the delivery of services to adult offenders, including executives and administrators of private foundations, executives, administrators, and staff of other state departments, the Legislature, and advocacy groups. The OOS

is responsible for establishing and maintaining collaborative partnerships with volunteers, volunteer organizations, local governments, and community providers to provide volunteer and self-help services within the California Department of Corrections and Rehabilitation (CDCR) prisons and re-entry and other services to parolees. In addition, the OOS oversees the statewide development and management of evidence-based substance abuse treatment and recovery programs for inmates and parolees and coordinates activities with multi-governmental funding agencies and public and private non-profit organizations to ensure cooperation in providing substance abuse services.

The OCE manages the adult academic and vocational education programs to improve offender skills and reduce recidivism.

The OPAS is responsible for the oversight and management of rehabilitative program utilization within CDCR institutions and parole units; fidelity of the programs provided by the Department in its continued efforts toward reducing recidivism; rehabilitative training for departmental staff; and the appropriate use of the funds allocated to CDCR for offender rehabilitative programming, personnel, hiring, and labor issues relative to current and expanded programming staffing, both at headquarters and in the field.

Specific duties include, but are not limited to:

- Responsible for statewide programs, policies, and procedures related to rehabilitative programs; coordinating with divisions under the purview of the Undersecretary, Operations to provide rehabilitative program services for adult inmates and parolees under the jurisdiction of the CDCR; developing operational procedures and policies for statewide usage and implementation; and providing direction for program planning.
- Brief and advise the Undersecretary, Operations, and CDCR executive management on matters concerning rehabilitative services and policy issues; represents CDCR before the Legislature on policy and budget issues; and confer with members of the public and representatives of national, state, and local governmental agencies to formulate and implement policies and procedures for rehabilitative services. Monitor expenditures to ensure accuracy and maintain budgetary constraints.
- Represent the Department to the public by attending conferences, symposiums, community events, and testifying before legislative committees regarding the needs of CDCR's rehabilitative programs. May act as the Undersecretary, Operations, in his/her absence.

ADDITIONAL QUALIFICATIONS

Candidates must have a thorough working knowledge of adult correctional and parole organizations, State government, and the issues currently faced by California corrections and parole. Candidates should have general knowledge of community organizations and the ability to foster partnerships in a correctional environment and represent the department before the Legislature and executive branches of government on various policies and procedures related to rehabilitative programs. Candidates must be able to communicate ideas logically and clearly, both orally and in writing, and must be a leader and motivator, using tact and persuasiveness in achieving results. Must also be able to analyze complex program issues and develop recommendations to resolve them. Specific skills, abilities, and characteristics include:

- Knowledge of CDCR's correctional divisions and programs, State government, and issues currently faced by the CDCR.
- Experience as a leader and motivator, using diplomacy in achieving results which demonstrates the ability to plan, organize, and direct multidisciplinary staff. Must also be able to analyze complex program issues at an executive level to recommend, develop, and implement effective courses of action; make independent, sound, ethical decisions regarding highly sensitive matters; and maintain confidentiality using collaborative, evidence-based processes.
- Knowledge of: principles, practices, and trends in public administration, organization, and management; techniques of organizing, program development and evaluation; methods of administrative problem solving; and principles and practices of policy formulation and development.
- Experience in executive, administrative, support services, and rehabilitative program management; and knowledge of appropriate techniques of statewide rehabilitative operations, including an executive's role for contributing to and achieving an equal employment opportunity workplace.
